Minute of Meeting on 14 April, 2021

Matters Arising

Email to Council for Rural Tourism Grant regarding signage, parking and town map has been repeatedly returned as undeliverable.

Correspondence

- Email received from Adam Ardrey regarding historical research. Agreed to reply thank you but not available for meeting.
- Bill McHugh has emailed Land Reform regarding community purchase of Skipness shop. Agreed that investigations must first be carried out with the community and then discussions with the Trust could follow. Bill has agreed to take this forward.
- EKREG meeting minutes received. Concern that future windfarm developments would not provide community benefit or opportunities for shared ownership. A letter has been sent to the media which has already generated interest.
- MAKI Area Community Planning Group minutes of latest meeting received.
 Anyone who wishes a copy to contact Jane.
- Community Council has received a quote for £70,500 for the installation of a replica Victorian fountain.

Community Benefit Dispersal

Applications are open for the month of May. An advert has been placed in the Argyllshire Advertiser, Facebook and Instagram. Sheila and CJ will organise collation of applications.

Tarbert Life

It is impossible to prevent downloading pictures from the website but it has now been made much more difficult to carry out. Google Analytics now being used on the website but it will take a few months to build up information.

The information boards on Marine Life and Churches have now been added to the website. The remaining information boards will follow. The Cenotaph Committee have collated information which will be forwarded to Alistair for inclusion on the website to co-inside with the centenary.

An application to Freasdail for financial assistance with any survey and legal costs that would be needed should a suitable premise become available was discussed. It was agreed that it was better to be prepared and to proceed with the application.

Tarbert & Skipness Housing

Alistair had distributed information relating to the sale of the Escart Estate prior to the meeting. Prior to applying to the Scottish Land Fund for a grant to purchase any land for housing needs it is necessary to show the support of the community. Alistair has compiled a sheet for signatures and David will compile and information leaflet. These will be distributed to Directors for collection of signatures. It was reinforced that time was of the essence here to enable TSCT to register as 'a person of interest.' The land concerned has previously been granted planning permission and is still shown on the local plan. If successful, advice will be available from other Agencies that will become involved.

TSCT has a meeting arranged with Fergus Murray, Argyll and Bute Council on 11/5/21.

The Trust has been awarded a grant of £24,000 from Crown Estate Scotland to recruit someone to work on the housing project.

Alex proposed a new Director to support this project but was referred to the minutes of the previous meeting where it was agreed not to introduce further Directors until the AGM. Alex also said that Fiona Jean Arnot has offered to help with survey work.

Covid-19

Money remaining from SLF, STV and the wind farms will fund the purchase of the chrome books for the school. There is £2,700 left within the Scottish Government funding – it was agreed that Jane would seek authorisation to use £1,500 of this to support the village hall with the purchase of a heater and excess electricity used because the doors were required to be open. Any remaining monies require to be used by the end of May.

Investing in Communities

No feedback yet from DTAS regarding additional funding. CJ will be leaving at the end of June.

Digital Update

Agreed to continue to use PureWestMedia. Jane, Alistair and Lorna would check funding for this
